Dear Potential Arts & Crafts Vendors,

This year, Kool-Aid Days will offer booth space for artisans and crafters to sell their work on the festival grounds in downtown Hastings. Those exhibits will be open from 9:30 am to 4 pm on Saturday, August 11, 2018. To qualify as an Arts & Crafts vendor, you may sell handmade articles, arts, and crafts that are your own work and home crafted. No food items may be sold in the Arts & Crafts area. No commercial items are allowed. Absolutely no jobbing will be permitted. This is done to ensure quality handcrafted products.

For each vendor, we supply an approximately 12'X12' space on the street or sidewalk. We do not provide any canopies or furniture and no electricity is available. Booth spaces will be on the south side of the Hastings City Auditorium near the Kool-Aid Stand and food vendors. We ask that you have everything unloaded and vehicles moved by 9 am, with sales to begin at 9:30 am.

If you are interested in having a booth at Kool-Aid Days 2018, please complete the attached application form and release and mail or email it to the designated address. Please supply pictures representative of the work you wish to sell. Application does not guarantee you a booth space. You will be notified by the Kool-Aid Board as soon as your application is approved and the registration fee of \$40.00 will be invoiced at that time.

We look forward to hearing from you so we can work together to make Kool-Aid Days 2018 the best ever!
