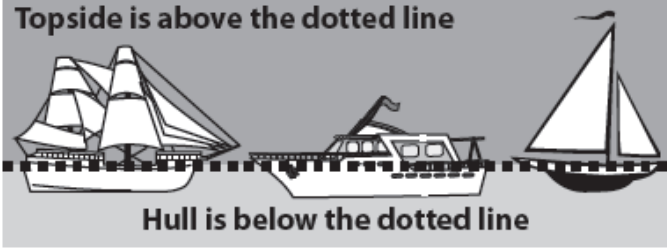


- Decorations that are not part of the boat's hull can be made of any material EXCEPT metal or glass. Be creative and compete for one of the design categories!
- Do not include pointed objects or sharp edges that could injure anyone handling the boat.
- If the topside is heavier than the hull, your boat will flip! Keep your boat's center of gravity LOW.
- If you have questions during construction about what is allowed, please contact: the Kool-Aid Days office.

ON RACE DAY

- Check-in with the race officials at the boat display area by 4 PM. **Only those who have registered by 4 PM will be allowed to race!**
- Be sure that all blanks on your entry form are complete and that it is signed by your parent or guardian! **Entries not accompanied by a signed registration form are automatically disqualified. Child must be present during race.**
- Boats built in the Extemporaneous category observe the age requirements of 5-12 ages only.
- Each entry will be assigned a number, which must be attached toward the front on each side of the boat. (Stickers will be supplied by the race supervisor.)
- After checking in, you may set your boat on display.
- Each boat will be removed from the water after each race, to be taken home.
